#### Cancellation fees

EPA cancellation fees apply when an EPA activity has been confirmed and is subsequently cancelled.

	% of cancellation fee
More than 10 days before the EPA activity	0%
More than 5 days and less than 10 days before the EPA activity	25%
More than 48 hours and less than 5 days before the EPA activity	50%
Within 48 hours of the EPA activity	100%

The fee is based on a percentage of the cancellation fee listed above, depending on when the EPA activity is cancelled. Any travel and accommodation costs incurred that cannot be re-scheduled or refunded will also be invoiced.

#### Other services

We can provide an invigilator for a knowledge test for a fee of £50.00 per apprentice or £100.00 per knowledge test session. Invigilation changes are subject to cancellation fees.

#### Payment terms
