Registration fees

The registration fee is invoiced when you register an apprentice with us. If an apprentice registered with us does not reach gateway, we will refund 100% of their registration fee. The remaining EPA fee is invoiced at gateway.

Cancellation fees

EPA cancellation fees apply when an EPA activity has been confirmed and is subsequently cancelled.

More than 10 working days before the EPA activity	0%
6 days to 10 working days before the EPA activity	25%
2 working days to 5 working days before the EPA activity	50%
Within 48 working hours of the EPA activity	100%

The fee is based on a percentage of the cancellation fee listed above, depending on when the EPA activity is cancelled. Any travel and accommodation costs incurred that cannot be re-scheduled or refunded will also be invoiced.
